## RULES AND REGULATIONS

**No purchase necessary to participate. A purchase will not improve chances of being selected.**

**Eligibility:** The Penn Station Cincinnati Athlete of the Month/Year program (the "Program") is open to all senior Greater Cincinnati, Ohio area high school students.

**Sponsors:** Penn Station, Inc., 1226 US Highway 50 Milford, Ohio 45150 and Penn Station Cincinnati Advertising Co-op, 1 West 4<sup>th</sup> Street Cincinnati, OH 45202.

**How to Nominate:** Nominations for the Contest may be made (i) online at [pscincy.com](http://pscincy.com), or (ii) by mailing a letter identifying the nominated student's name, high school, and the name and complete address and phone number of the person submitting the nomination to: Penn Station Athlete of the Month, 1 West 4<sup>th</sup> Street Cincinnati, OH 45202. Nominations are only accepted for months of October, November, December, January, February, March, April and May. Selections are made 2 months prior to the month in which the student is awarded. Selections are made in the months of August, September, October, November, December, January, February and March. Nominations from one month are not carried forward to the next month, but there is no limit to the number of times non-winning students may be re-nominated.

**Selection Process:** Penn Station Athlete of the Month/Year winners will be selected by qualified community representatives based upon the nominees' excellence in athletics, citizenship, accomplishments and qualifications. Winners will be notified via their high school principal or athletic director. The potential winners (or their parent/legal guardian if a winner is a minor in his/her place of residence) will be required to complete and return a student information sheet, submit a photo and school logo, and sign and return a declaration of compliance and, except where prohibited, a liability/publicity release, all of which must be received by Penn Station within the time period indicated in the notification letter in order to claim his/her prize from Penn Station Cincinnati Advertising Co-op. Monthly winners will be featured on WXIX, WKFS-FM, WCKY-AM and WLW-AM. Representatives of the potential winners' schools must provide written authorization/proof of a winner's eligibility within the time period indicated in the notification letter. During the Athlete of the Year selection process, representatives of each Athlete of the Month winner's school may be required to provide updated information to Penn Station regarding the school's Athlete of the Month student(s). Penn Station reserves the right to name an alternate winner if a potential winner cannot be contacted or fails to return the declaration of compliance and liability/publicity release by the specified date, or if representatives of the potential winner's school fail to submit the required information by the specified date.

The School Spirit Award winner will be selected by qualified community representatives based upon the school that has the most spirited Athlete of the Month winner presentation.
